ASHLAND TO PAINTSVILLE

Take Route 23 South. After passing the 9 mile marker there is a CITGO station on the right side of the highway. Approximately $\frac{3}{4}$ mile from the 9-mile marker there is a sign "Paintsville-Route 321" with a left turn lane. Turn left onto Route 321. After approximately $1\frac{1}{2}$ miles, Route 321 will intersect with Route 460 and Route 40 at a four way intersection with a traffic light. Turn left at the intersection. After the turn, you will be on Route 40 and this road will take you toward Paintsville and the Perkins Center.

LEXINGTON TO PAINTSVILLE

When leaving Lexington on I-64 and after passing the Winchester exits, there is a sign designating the Mountain Parkway. Turn right onto the Mountain Parkway and stay on the Parkway until you come to a traffic light at the outskirts of Salyersville. Proceed straight at the light. Approximately 2 miles past the traffic light (after passing a number of convenience stores and fast food restaurants) you will see yellow flashing caution lights and a sign for Paintsville and Route 460. Turn left onto Route 460. Route 460 will take you east toward Paintsville. After approximately 15 miles, you will come to a traffic light. Proceed through the light and drive for approximately 1 mile. You will then arrive at a four-way intersection for Routes 321, Route 460, and Route 40 (the Johnson County Courthouse can be seen on your right as you approach the intersection). Proceed straight through the intersection. You will be on Route 40 East and this road will take you toward Paintsville and the Perkins Center.

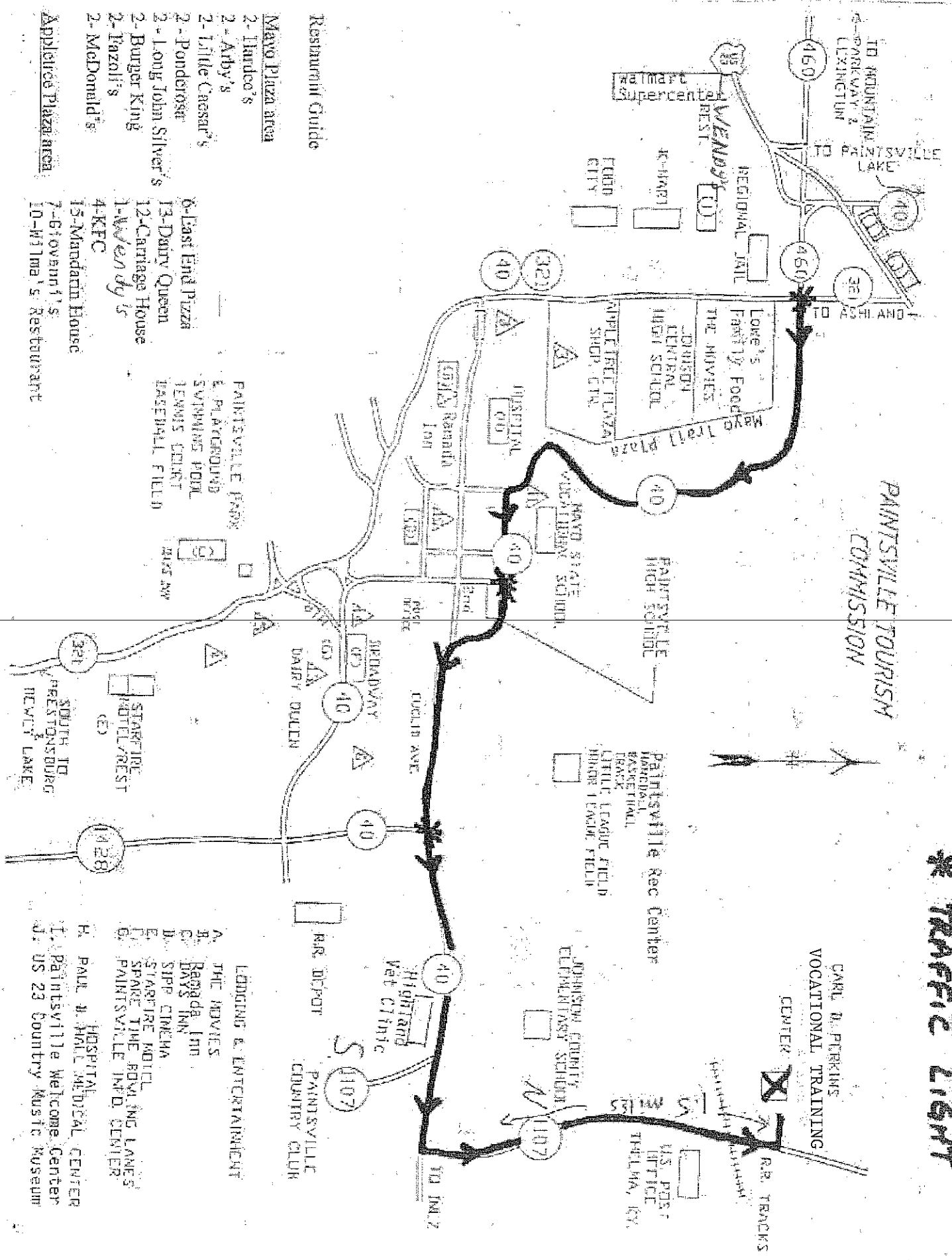
HAZARD TO PAINTSVILLE

Take Route 80 North to the Route 23 intersection near Prestonsburg. Turn left on the overpass onto Route 23 North to Paintsville. Proceed on 23 north for approximately 15 miles until you see the exit sign for Paintsville. Turn left on the off-ramp. There will be a traffic light at the base of the ramp. Turn right. Proceed for approximately 1 mile. There will be a traffic light at a four way intersection for Routes 321, Route 460, and Route 40 (the Johnson County Courthouse can be seen on your right as you approach the intersection). Proceed straight through the intersection. You will be on Route 40 East and this road will take you toward Paintsville and the Perkins Center.
