There was discussion amongst members and guests regarding live video trainings. There was discussion amongst the members and guests regarding the tracking of zoom analytics. There was further discussion regarding the focus topic(s) and proposed schedule of trainings. A power point presentation titled 'Employer Education & Engagement Subcommittee – Employer Lunch & Learn Series Outline 4/21/23' was shared with the attendees via screen share. There was interpretation and discussion of the power point presentation. Luv'Tesha commented that a recommendation had previously been made to add adult education and apprenticeships to the Lunch & Learn Series topics. Chair, Merry Reid Sheffer joined the zoom meeting and was provided a brief verbal update of what had been discussed in the meeting. There was discussion amongst the members and guests regarding the Lunch & Learn Series, its topics and the intent of the committee to provide quarterly learning modules. There was discussion amongst member and guests regarding intro to etiquette, myths, and range of disability experience. There was discussion amongst members and guests regarding Coalition creation and replication. There was discussion regarding former committee member, Michael Rimer's resignation and subsequent replacement Ramone Blair. Notes were made regarding Ramone's future absorption of the portion of the series related to creating an accommodations process. There was brief discussion of member, Zach Morgan's portion of the series related to demystifying regulatory issues around disability. There was discussion amongst members and guests regarding the order of flow for the topics and prioritizing focus to match the Governor's priorities. There was an idea introduced to add an Employment First training module to the series. This idea was received positively and sparked discussion amongst members and guests. Members and guests worked to create order in the flow of the series modules. There was discussion of adding an OVR services module to the training series. There was discussion of timeframe parameters of the training modules. There was discussion held of public promotion of the series and dates in which the series will be launched/held.

Competitive Integrated Employment (CIE)

The Workforce Innovation and Opportunity Act (WIOA) defines competitive integrated employment (CIE) as work that is performed on a full-time or part-time basis for which an individual is:

- Compensated at or above minimum wage and comparable to the customary rate paid by the employer to employees without disabilities performing similar duties and with similar training and experience;
- Receiving the same level of benefits provided to other employees without disabilities in similar positions;
- At a location where the employee interacts with other individuals without disabilities;
 and
- Presented opportunities for advancement similar to other employees without disabilities in similar positions.

All presentations must be in line with this definition of CIE!
