## **ASHLAND TO PAINTSVILLE (from North)**

Take Route US Highway 23 South to the 9 Mile marker. There is a service station on the right side of the highway. Approximately 34 mile from the 9 Mile marker there is a sign "Paintsville-Route 321" with a left turn lane. Turn left onto Route 321. After approximately 1 ½ miles, Route 321 will intersect with Route 460 and Route 40 at a four-way intersection with a traffic light. Turn left at the intersection on to Route 40E. This road will take you toward Paintsville and further on to the Perkins Center (approximately 4 miles). After passing the Paintsville Golf Course and a cutthrough that runs parallel with Route 40E and the Levisa Fork of the Big Sandy River, you will turn Left on to Route 1107 (North). The Perkins Center is approximately 1 mile on the left, just past the Thelma Post Office and after crossing train tracks. We are a white building with 5 floors of dormitory rooms sitting approximately 200 yards from the highway.

## **LEXINGTON TO PAINTSVILLE (from West)**

When leaving Lexington on I-64 and after passing the Winchester exits, there is a sign designating the Mountain Parkway (Exit 98). Take the exit onto the Mountain Parkway and stay on this route until you reach Salversville. Proceed through all the traffic lights (approximately 2 miles), you will see the last light is a flashing traffic light and a sign for Paintsville/Route 460. Turn left onto Route 460. You will travel approximately 15 miles east toward Paintsville. You will proceed through two traffic lights which will bring you to a four-way intersection for Routes 321, Route 460, and Route 40 (the Johnson County Courthouse is on the right as you approach the intersection). Proceed straight through the intersection. This road will take you toward Paintsville and further on to the Perkins Center (approximately 4 miles). After passing the Paintsville Golf Course and a cut-through that runs parallel with Route 40E and the Levisa Fork of the Big Sandy River, you will turn Left on to Route 1107 (North). The Perkins Center is approximately 1 mile on the left, just past the Thelma Post Office and after crossing train tracks. We are a white building with 5 floors of dormitory rooms sitting approximately 200 yards from the highway.

## **HAZARD TO PAINTSVILLE (from South)**

Take Route 80 North to Route 23 intersection near Prestonsburg. Turn left just over the overpass on to Route 23 North to Paintsville. Proceed on Route 23 North for approximately 15 miles until you see the exit for Paintsville. There is a traffic light at the bottom of the ramp. Turn right. Proceed for approximately 1 mile which will bring you to a four-way intersection for Routes 321, Route 460, and Route 40 (the Johnson County Courthouse is on the right as you approach the intersection). Proceed straight through the intersection. This road will take you toward Paintsville and further on to the Perkins Center (approximately 4 miles). After passing the Paintsville Golf Course and a cut-through that runs parallel with Route 40E and the Levisa Fork of the Big Sandy River, you will turn Left on to Route 1107 (North). The Perkins Center is approximately 1 mile on the left, just past the Thelma Post Office and after crossing train tracks.
